## Need for rational assessment of Lancaster General Health

It is natural for the public to look at this colossus of a local health provider with reverence. We often suspend critical judgment as we do for the entire health care system because, deep down, we harbor a sense of dependency.

But there needs to be a spotlight placed on LGH. And in fairness, next week we will spotlight their response.

(1) Its second highest profits in the state are mainly the result of market dominance, something they are trying to perfect by crowding out the one remaining viable competitor, Ephrata Community Hospital.

(2) Because LGH market dominance enables it to charge insurance companies more, insurers in turn charge more to Lancastrians for coverage. So LGH's huge profits are in part coming from our pockets.

(3) LGH, a non-profit 'public charity' is one of the least charitable hospitals in the state! We know not what it is doing with its vast earnings, but we do know they are not being directed adequately towards local public health and education.

(4) There is total lack of transparency, with media and public being banned from all LGH trustee and committee meetings except for the annual public meeting, and that one goes unnoted and unreported by the Lancaster press. (It was held last November, but not a word was printed about it before or after.)

(5) Finally, management at LGH is totally self-perpetuating, with current trustees choosing future ones. There is no public input.

With LGH, we have a non-profit institution that acts like a Fortune 100 for-profit corporation that pays no dividends. We hope to help LGH find its way.

## New location proposed for LT fire house

A new location has been proposed for the controversial Lancaster Township emergency services center, one that could potentially assuage the concerns of many of the project's past opponents, according to Michael Rowen of the School District of Lancaster board. Rowen discussed the proposal at the board's Tuesday evening meeting, calling it "*a possible win-win situation.*"

Rather than sitting behind Planet Fitness with private access drives connecting Atkins Avenue and Millersville Pike, the new location would front on

Millersville Pike, sitting alongside the Planet Fitness parking lot. A one-way private drive from Atkins leading to the fire house would run along the Manor House Apartments' property line and behind Planet Fitness. It would begin at a point that would minimize travel along the residential Atkins Ave.

According to Rowen, the newly proposed location would not require the relocation of district athletic fields, thus making it unnecessary to consider clearing portions of the wooded areas in the Lancaster Township Community Park.

## **EDITORIAL: District Attorney's logic is contradictory**

District Attorney Craig Stedman is critical of Judge Jeffery Wright for only sentencing Ryan Lebus to 5 to 12 years in state prison for driving drunk and causing a fiery 2008 accident that killed a mother of three, badly burned a grandmother, and injured the burned woman's daughter...

It is tragic that the accident occurred. But 5 to 12 years

in prison is not a rap on the knuckles. We side with Judge Wright that the punishment must take into consideration more the nature of the crime, not the tragic outcome. Lebus didn't just get three months for driving under the influence, which normally would be a long sentence had no accident occurred. He received 5 to 12 years!
